4. The Artist agrees to provide upon request certificates of insurance showing the University of Massachusetts Dartmouth Trustees, their agents, servants and employees...
5. This contract shall be null and void, and of no force and effect unless a duly executed copy is delivered to the Student Activities, Involvement & Leadership Office...
