Honors Abstract.

Nurses' and Students' Knowledge and Attitudes Towards Pain Management

PROBLEM: Deficits in knowledge and attitudes regarding pain treatment exists among nursing students. Few studies have explored whether nursing practice and/or further training on pain management impacts student knowledge and attitude about pain treatments.

PURPOSE: This study identified the knowledge and attitudes towards pain management in senior level nursing students in one baccalaureate program and compared knowledge and attitude levels with practicing nurses in one RN-BS program.

METHOD: Data was collected from a convenience sample of 40 senior level nursing students and 10 RN-BSN students by online survey using the Nurses Knowledge and Attitudes Survey Regarding Pain (NKASRP). Scoring of the tool was based on participant responses to 21 true/false and 13 multiple choice questions and two case studies. Scores of the senior level nursing students were compared to those of the practicing nurses.

RESULTS: Analysis of the data using the Statistical Package for Social Sciences, (SPSS), showed that practicing nurses scored higher on the NKASRP. Questions about the indication for use, peak time and duration of opioids were among those with low scores. Also three questions related to the topic of addiction scored low. Results of the case studies showed that participants would under treat pain.

CONCLUSION: This study suggests there are gaps in basic nursing knowledge about pain assessment, opioid analgesia, and the risk of addiction. Since student nurses (μ =67.3%) scored lower than the practicing nurses (μ =76.2%), it could be concluded that education in pain management may need to be fortified. Implications are that the nursing education curriculum may need to include more instruction on pain management.


