Practice course application process for Field Placement & Simulation Courses

You may not enroll via Student Self-Service for these courses, you must complete an **application** form.

- **Field Placement:** applications **accepted**, on a rolling basis **beginning Monday, March 4**
- **Simulation Practice:** applications **accepted**, **Monday, March 4-Saturday, March 16**

Restrictions on summer registration

No student may take more than six (6) credits during the summer session without the prior written approval of the associate dean, who may not approve more than nine (9) credit hours during the summer session.

The associate dean may not approve more than six summer credit hours for a part time student who has not completed two years of part time study.

Students who have not completed a year of full-time study or its equivalent (24 credits) may only enroll in those classes that are designated as 1L.

For students enrolled in Joint Degree Programs, the above stated regulations apply to the total number of credits from all degree programs combined. (Student Handbook § 8).

MPRE Graduation Requirement

Every student who registers to take the MPRE must report their registration, and report their results upon receipt, to Director of Academic Success.

The MPRE is administered three times each year in March, August, and November

Financial Aid for Summer Session

Law Financial Aid Services will email Cost of Attendance (COA) budgets along with instructions for obtaining federal loans for summer 2024 as soon as practicable.

Eligibility for Federal Loans:

- You *must* have a completed FAFSA for the 23/24 academic year.
- You *must* be enrolled at least half-time (3 credits) for the summer session.
- You *must* have received federal loan funds for fall and/or spring semester.

Financial Aid Options

Federal Direct Unsubsidized Loan – Unused portion for 2023-2024, up to annual maximum allowed (\$20,500); not to exceed Summer COA.

Federal Direct Graduate Plus Loan – Up to Summer COA total.

Summer Tuition and Fees

Tuition: \$1,200.00 per credit
Registration Fee: \$30.00 (one-time fee)
Technology Fee for Online (\$150.00 per course)
