For example, if you have exams scheduled at 6:30 p.m. on Monday and 9:30 a.m. on Tuesday, you have an examination conflict. If you have exams scheduled at 1:30 p.m. on Monday and 9:30 a.m. on Tuesday, you do not have an examination conflict. If you have an examination conflict, you must submit a petition within two weeks of the close of the published add and drop period. If you do not file a timely petition, you will be deemed to have waived your right to object to the conflict.
